# **Product Description:**

**DAP® WELDWOOD®** All Weather Outdoor Carpet Adhesive is a high strength, weatherproof adhesive designed for the permanent installation of most outdoor carpets and artificial turfs. The rubber based, fast grab formula resists curling.

## **Suggested Uses:**

For permanently bonding most outdoor carpets, including rubber-backed and poly-backed artificial turfs to asphalt, concrete and wood.

**DAP® WELDWOOD® All Weather Outdoor Carpet Adhesive** is formulated for use with rubber and polybacked outdoor carpet and artificial turf. This product is not recommended for installing tile or carpet backed with urethane or vinyl. Do not use over tar or felt paper. For outdoor use only.

## **Performance Characteristics:**

**DAP® WELDWOOD®** All Weather Outdoor Carpet Adhesive may be used over treated and untreated wood (care should be taken to ensure that treated wood contains a low moisture content before applying adhesive) and concrete. Can be used in cool and hot weather (45° F to 100° F). Resists rain, snow, ice and freezing. The freeze/thaw stable formula is weatherproof, so the threat of rain 24 hours after installation is not a problem.

# Surface Preparation & Application:

# **Preparation:**

- 1. Temperature of floor, floor covering and adhesive must be 45° F to 100° F unless otherwise recommended by floor covering manufacturer.
- 2. When using in confined outdoor areas, provide adequate ventilation so that vapors cannot concentrate in one place.
- 3. Bonding surfaces must be clean, dry and free of wax, grease, dirt, paint, other contaminates and moisture due to hydrostatic pressure.

#### **Coverage Will Increase or Decrease According To Floor Surface**

#### **Application:**

- 1. Lay out floor covering according to manufacturer's instructions.
- 2. Apply adhesive evenly to clean floor using recommended trowel size.
- 3. "Legs" must develop before lowering the carpet into the adhesive. To determine if "legs" have developed, place a scrap piece of material into the adhesive-then pull the scrap away. If strings or "legs" appear, proceed to step 4. If no "legs" appear, wait 5 minutes and repeat this step.
- 4. Once "legs" develop, lay the floor covering into the adhesive. Roll in both directions with a 75 pound roller. If installing foam or sponge backed carpet, use a cardboard carpet core to smooth out the carpet.
- 5. If bubbles occur, insert an awl in the center of the bubble to allow the vapor to escape, then smooth it out..
- 6. If necessary to make seams, follow the manufacturer's instructions to seal the seams and complete the installation.
- 7. Do not expose to heavy traffic for 24 hours.

Product has 12-18 month shelf life when stored in a cool, dry place. Product will withstand 5 freeze/thaw cycles without affecting performance. Follow original directions for reuse. Maximum storage time will be achieved if storage container has minimal air entrapment with a tight lid.
