## 4. First-aid Measures

# 5. Fire-fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** FLASH POINT IS LESS THAN 20°F. EXTREMELY FLAMMABLE LIQUID AND VAPOR!Water spray may be ineffective. # 10. Stability and Reactivity
