OSHA's Standard for Respiratory Protection, 529 CFR 1910, 134, requires Employers to implement a change schedule for all canisters and cartridges when there is not an end of service life indicator on the cartridge or canister. The employer shall describe the respirator program the information and data relied upon and the basis for the canister and cartridge change schedule and the basis for reliance on the data. This schedule must be site specific and take into consideration worksite humidity, worker breathing rate as well as contaminant concentrations.
