# 4. First-Aid Measures

# 5. Fire-Fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** FLASH POINT IS LESS THAN 20°F. EXTREMELY FLAMMABLE LIQUID AND VAPOR!Water spray may be ineffective. Closed containers may explode when exposed to extreme heat. # 6. Accidental Release Measures

### 10. Stability and Reactivity
