### 4. First-Aid Measures

### PERSONAL PROTECTION

## 10. Stability and Reactivity

**CONDITIONS TO AVOID:** Avoid all possible sources of ignition.

**INCOMPATIBILITY:** Incompatible with strong oxidizing agents, strong acids and strong alkalies.
